This Privacy Policy explains how **T J Forever Solar Ltd** ("we", "us", "our") collects, uses, and protects your personal information when you visit our website or use our services.

1. Who We Are

2. What Information We Collect

We may collect and process the following types of personal data:

a) Information you provide directly

- Your name, address, and contact details (phone number, email)
- Installation or quotation details
- Payment information (where applicable)
- Any correspondence or communication with us
- Photos or documents you share for site surveys or installations

b) Information we collect automatically

When you visit our website, we may automatically collect:

IP address and browser type

- Information about how you use our website (e.g. pages visited, time spent)
- Cookies and similar technologies (see Section 9)

c) Information from third parties

We may receive data from:

- Suppliers or contractors involved in your installation
- Accreditation or warranty bodies (e.g. MCS, RECC)
- Finance providers (if you apply for finance)

3. How We Use Your Information

We use your personal data for the following purposes:

- To provide quotations and carry out solar installations or related services
- To manage your account, project, and communications
- To process payments and issue invoices
- To register your system with certification or warranty schemes (e.g. MCS, DNO, manufacturer)
- To comply with legal and regulatory obligations
- To send you updates about your installation or maintenance
- To send occasional marketing or promotional communications (only if you have given consent or where legally permitted)
- To improve our website, products, and services

4. Legal Basis for Processing

We rely on one or more of the following lawful bases to process your personal data:

- **Contract:** processing is necessary for the performance of a contract or to take steps before entering into one.
- Legal obligation: to comply with applicable laws and regulations.
- **Legitimate interests:** for business operations, such as improving our services and preventing fraud.
- **Consent:** when you have given explicit permission, e.g. for marketing communications.

You can withdraw consent at any time by emailing comms@tjforeversolar.uk.

5. How We Share Your Information

We may share your data with trusted third parties where necessary to deliver our services, including:

- Installation and maintenance subcontractors
- Certification bodies (MCS, RECC)
- · Warranty and finance providers
- IT, hosting, and email service providers
- Professional advisers (accountants, legal advisors, etc.)
- Regulatory authorities, if required by law

We will never sell your personal information to third parties.

All third parties are required to respect your data privacy and process your information in accordance with data protection law.

6. Data Retention

We will keep your personal data only as long as necessary to:

- Provide our services and fulfil our contract with you;
- Meet our legal and accounting obligations; or
- Resolve any disputes.

Typically, we retain customer records for 6 years after the end of the contractual relationship, unless a longer period is required by law (e.g. for warranty or insurance purposes).

7. How We Protect Your Data

We take appropriate technical and organisational measures to protect your personal data from loss, misuse, or unauthorised access, including:

- Secure password-protected systems
- Encrypted communications
- Limited staff access on a need-to-know basis
- · Regular data protection training

8. Your Rights

Under data protection law, you have the right to:

- Access the personal data we hold about you
- Rectify inaccurate or incomplete information
- Erase your personal data ("right to be forgotten")
- Restrict or object to processing of your data
- Data portability receive a copy in a structured, commonly used format
- Withdraw consent for marketing or other optional uses
